III. OLD BUSINESS

(A) Ordinance Enacting a New Section 27-81 of the Rolla City Code Regarding the Obstruction of Mailboxes: Police Chief Sean Fagan stated the reason for requesting the subject ordinance is because many residents are not receiving their mail due to the blocking of mailboxes.

City Counselor Carolyn Buschjost read the following proposed ordinance for its final reading, by title. ORDINANCE NO 4324: AN ORDINANCE ENACTING ARTICLE VI - STOPPING, STANDING & PARKING, SECTION 27-81 OF THE GENERAL ORDINANCES OF THE CITY OF ROLLA, MISSOURI, KNOWN AS THE CODE OF THE CITY OF ROLLA, MISSOURI RELATING TO PARKING TO OBSTRUCT MAILBOXES. A motion was made by Williams and seconded by Morris to approve the proposed ordinance. A roll call vote on the motion showed the following: Ayes; Eudaly, Meusch, Jordan, Williams, Hines, Jung, Woolley, Bowe, Crowell, Morris, and Miller. Nays; None. Absent; Long. Motion carried. The ordinance passed.

(B) Ordinance Amending Section 27-62 of the Rolla City Code Pertaining to Seatbelts: Police Chief Sean Fagan emphasized he did not recommend this ordinance in order to write more tickets. Rather, it is a public safety concern. Chief Fagan said it is a way to educate the public about the importance of wearing seatbelts. He said he understands the reluctance on passing this ordinance. Chief Fagan added he was advised that if the subject ordinance is approved, the fine for not wearing a seatbelt could not be higher than \$10.

Both Chief Fagan and Councilman Hines reported they have received unanimous opposition to this ordinance from those who have contacted them about it.

City Counselor Carolyn Buschjost read the following proposed ordinance for its final reading, by title. ORDINANCE: AN ORDINANCE AMENDING ARTICLE IV, EQUIPMENT ON VEHICLES, SECTION 27-62 OF THE GENERAL ORDINANCES OF THE CITY OF ROLLA, MISSOURI, KNOWN AS THE CODE OF THE CITY OF ROLLA, MISSOURI RELATING TO SEATBELTS. A motion was made by Williams and seconded by Eudaly to approve the proposed ordinance. A roll call vote on the motion showed the following: Ayes; None. Nays; Jung, Miller, Jordan, Hines, Woolley, Williams, Bowe, Crowell, Meusch, Eudaly, and Morris. Absent; Long. Motion failed. The ordinance failed.

(C) Ordinance Amending Section 27-92 of the Rolla City Code Pertaining to Parking on Vichy and Vienna Roads: Public Works Director Steve Hargis indicated this issue has been discussed a couple of times and staff has withdrawn its recommendation of no parking on both sides of Vichy Road. He said staff is recommending no parking on the area's north intersections of Vienna Road, Roseglade Road, and Meadowbrook Drive as shown on the map contained in the agenda materials.

City Counselor Carolyn Buschjost read the following proposed ordinance for its final reading, by title. ORDINANCE NO. 4325: AN ORDINANCE AMENDING SECTION 27-92 OF THE GENERAL ORDINANCES OF THE CITY OF ROLLA, MISSOURI KNOWN AS THE CODE OF THE CITY OF ROLLA, MISSOURI, RELATING TO PARKING. A motion was made by Williams and seconded by Eudaly to approve the proposed ordinance. A roll call vote on the motion showed the following: Ayes; Miller, Bowe, Woolley, Williams, Hines, Jung, Meusch, Jordan, Morris, Eudaly, and Crowell. Nays; None. Absent; Long. Motion carried. The ordinance passed.

(D) Ordinance Authorizing the Mayor to Execute Amendment No. 3 with HNTB Corporation – Westside Transportation Master Plan Agreement: Public Works Director Steve Hargis explained Amendment No. 3 would complete the final plans for contract documents relating to the Route 72 extension.

After a brief discussion, City Counselor Carolyn Buschjost read the following proposed ordinance for its final reading, by title. ORDINANCE NO. 4326: AN ORDINANCE AUTHORIZING THE MAYOR OF THE CITY OF ROLLA, MISSOURI TO EXECUTE ON BEHALF OF THE CITY OF ROLLA, MISSOURI AMENDMENT NO. 3 TO PROFESSIONAL SERVICES AGREEMENT BETWEEN THE CITY OF ROLLA, MISSOURI, AND HNTB CORPORATION. A motion was made by Eudaly and seconded by Hines to approve the proposed ordinance. A roll call vote on the motion showed the following: Ayes; Williams, Jordan, Jung, Eudaly, Woolley, Miller, Bowe, Crowell, Meusch, Morris, and Hines. Nays; None. Absent; Long. Motion carried. The ordinance passed.
